#### **ATTACHMENT 1-2**

#### A. STATEMENT OF FACTS

Emigration Improvement District is a special service district in Salt Lake County. (Hereafter "EID").
 On August 6, 2013, EID announced to residents within its tax district that it desired to obtain a 1.6 million dollar loan from the State of Utah for the apparent purpose of drilling a new well to meet the future requirements of its customers. (See Exhibit A, Letter EID, dated August 6, 2013.)

3. At the trustee meeting in September, and an Emigration Canyon resident and customer of EID, raised several questions concerning the management of EID. In particular, asked if the remuneration of Mr. Fred Smolka, Manager and Treasurer of EID, in the amount of \$120,000 was appropriate due to the apparent financial difficulties of EID. Moreover, according questioned Mr. Fred Smolka as to the employment of his brother Joe Smolka in light of Utah Code 17B-1-110 forbidding nepotism. The also inquired as to the employment of Ms. and Mr. Bergstrom, Mr. Smolka's daughter and son-in-law, as well as Mary Smolka, his wife.
4. The found the chairman and trustees evasive and unresponsive to his questions.

5. Shortly thereafter, Mr. Cramer published a letter announcing his candidacy for EID Trustee to replace the incumbent Mr. Mark Stevens. Believing that the trustees were not acting in the best interest of its tax district, campaigned extensively for the election of Mr. Cramer even though he had never met him prior to the election.

6. After the unsuccessful election of Mr. Cramer in November, **Sector** examined the budget and organizational minutes of EID. **Sector** discovered that the organization had spent 1.5 million in "Exploration Fees" since 2004 even though they had neither applied for a drilling permit with the Utah Division of Water Rights prior to 2013 and had given no explanation for the substantial costs in their organizational minutes.

## **B. COMPLAINT**

1. On December 12, 2013, submitted a GRAMA request to EID concerning the				
aforementioned transactions.	On January 29, 2014,	contacted Mr. Hawkes, assistant		
manager of EID, to discuss the GRAMA request. The next day, Mr. Hawkes posted a letter on				
door stating that his a	ccount with EID was overdu	e 30 days past the date of billing, and that		
water service would be disconnected in two days if he did not render payment to EID before 6 p.m. the				
next day. Exhibit B, letter predated to January 9, 2013; Exhibit C, Notice of Water Termination.				
2. The following day,	rendered payment to Mr.	Hawkes under protest.
