After both the Utah Division of Environmental Quality ("**DEQ**") and Emigration Improvement District ("**EID**") refused to disclose lead-contamination test results in almost identical proceedings now pending before the Utah State Records Committee (case nos. 20-44 and 20-62), Appellant commenced legal action against the Appellees upon receiving confirmation from the legal representative of EID Jeremy R. Cook that all public records of EID are maintained at the private residence and in the sole physical custody of the Appellees.

The district court ruled that the Appellees where not necessary parties to the litigation under Rule 19 (a) of the Utah Rules of Civil Procedure, not subject to GRAMA provisions and granted the motion to dismiss without oral arguments thereby striking evidence that the Deputy Mayor of Emigration Canyon is concurrently a director, officer and registered agent to the Appellee Simplifi Company.

During the proceedings before the district court, Appellees through Utah Attorney Cook failed to contest the legal standing of the "dba entity" of the Appellant

"Emigration Canyon Home Owners Association" to commence and/or maintain the present action as currently being argued and adjudicated by EID through Utah Attorney Cook under Case no. 20200295-CA before this Court (see No. 7 below).
