**Council Member Raile** introduced the Emigration Canyon Metro Township Council.

**Mr. Shane Topham**, Attorney, spoke under "Citizen Public Input" regarding his qualifications as an attorney for Emigration Canyon Metro Township. He has worked for Jones, Waldo, Holbrook and McDonough for 33 years and has been an attorney for Cottonwood Heights City for 12 years. He also has experience with commercial litigation, real estate transactions, municipal law, city incorporation, drafting ordinances and working with Mayor's and Council's to establish new policy and procedures and is familiar with the public process.

**Council Member Raile** asked what the billing rate would be.

Mr. Topham stated between \$200 - \$220 an hour.

Council Member Brems asked in what capacity he would work with Salt Lake County District Attorney's Office.

Mr. Topham stated he believes the Council should hire their own legal counsel who can engage with the community and have a good working relationship with Salt Lake County District Attorney's Office.

Council Member Brems stated if Salt Lake County gives the Township the county roads and someone is injured or killed and sues the Council, how will the Council afford to defend themselves.

Mr. Topham stated the Township will need to get coverage and that is typically done through Utah Local Government Trust.

Council Member Hawkes asked what an estimate would be to get the Council running smoothly.

Mr. Topham stated it depends on how much the Council relies on Salt Lake County ordinances and services. If ordinances need to be altered or service contracts need to be created, that will cost more.

### Review of Attorney's

**Council Member Smolka** stated there are two qualified candidates and Mr. David Church, Attorney, was the cheapest.

**Council Member Brems** stated Mr. Church also has a son, Matt Church, who can also provide services for a lesser amount.

**Council Member Hawkes** stated whoever the Council retains needs to be able to provide feedback specific to the Council's needs and be dedicated.

**Council Member Raile** stated if the Council chooses to retain Mr. Church, all conflict of interests could be avoided and the process to work through the set-up would be quicker. Mr. Church said that once he is retained the Council will be on his radar and will watch everything that is being done. A letter of expectations could be drafted and sent to Mr. Church.

**Council Member Hawkes** stated the Council's expectations needs to be clear.

**Council Member Smolka** stated he would like to see a prepared proposal and then present it to Mr. Church to get his feedback.

**Council Member Brems** stated the hourly rate needs to be nailed down and what the minimum costs are to set-up.

**Council Member Hawkes** stated the Council needs to have a budget in mind to see if Mr. Church is on the same page.

**Ms. Rita Lund**, East Township Representative, Township Services, stated Salt Lake County's District Attorney's Office will not be providing an attorney for any of the Metro Townships or Planning Commissions. The letter should include an attorney for the Planning Commission.

**Council Member Raile** asked the Council Members to send questions they have for Mr. Church.

Council Member Hawkes, seconded by Council Member Brems, moved to go forward with a proposal and additional questions to David Church for legal services. The motion passed unanimously, showing that all Council Members present voted "Aye."



## Telephone Services

**Council Member Hawkes** stated she has reviewed answering services that charge based on number of incoming calls and what type of service level requested, the starting cost for one service is \$59.00.

**Mr. Tyler Tippetts** stated he uses a service called phone.com that is \$34.00 a month for unlimited calls and call forwarding.

**Council Member Raile** stated Council Member Hawkes will research answering services and come back to the Council with options.

**Council Member Raile** asked if the Council can use the UFA Fire Station address as their physical address.

**Mr. Conn** stated he asked the attorney to include that language into the agreement.

**Council Member Raile** stated the Council should table the decision until they hear back from the fire district.



### Legislative Update

- One-percent local option sales tax distribution.
- Require all Metro townships to pool together class c road funds.
- Change the Metro Township budget cycle to calendar year.
- Clarify language to allow Metro Township meetings to be transcribed by recording only.
